Written Warranty

This is a suggested cover part Limited Warranty and regulations pertaining to each suggested part are stated here after:

1. **METALWORK:** Provided is a three Year Limited Warranty, from effective date stated herein, on all metalwork and framework, to include welding and the application of materials utilized in making collision repairs against cracking, flaking, peeling or deterioration, excluding rust repair.

2. **PAINTING, STRIPES AND DECAL:** Provided is a three year LIMITED WARRANTY, from effective date stated herein on painting related painting and paint work against solvent blistering, peeling, flaking, and excessive loss of pigmentation, and, a three LIMITED WARRANTY on the application and adhesion of decorative stripes and decal.

3. **MECHANICAL REPAIRS:** Provided is a three year LIMITED WARRANTY, from effective date stated herein, on all mechanical repairs pertaining to original collision damage.

4. **PARTS:** Provided is a three year LIMITED WARRANTY, from effective date stated herein, unless manufacturer's warranty is less or more, on new parts installed by or at the Shop. (Please Note: Shop warranty does not exceed manufacturer's warranty.)

5. **SECTIONS 1-4:** The shop will repair, replace, or replace a body in its option any item in section 1-4, when claim is made while the present owner stated herein owns the vehicle, unless caused by or damaged resulting from care, misuse, use, maintenance, or care of the vehicle. **THIS WRITTEN WARRANTY shall be null and void if the repair is altered, adjusted or tampered with by any person not authorized by Warranty Director.**

6. **SPECIFICALLY EXCLUDED:** (A) Incidental cost, such as towing fee, car rental charges, travel expenses, or accessories and components which are not specifically covered by this LIMITED WARRANTY, nor are consequential damage such as damage to other accessories and components resulting from a defective part or installation of such part installed or repaired during the repair. (B) Rust . . . Surface rust, rust through, and/or damage caused by wetting of interior or exterior panels is not covered. **THIS STATES ALL THE LIMITED WARRANTIES made by the Shop and contains the only promises for which it will be responsible.**

7. **CUSTOMER'S OBLIGATIONS:** In order to obtain the benefits of this warranty, the owner of the vehicle must do the following: (A) Present the owner's copy of this warranty document to the mechanic before requesting warranted repairs or parts; (B) Have any warranted repair, adjustment, or inspection made only at the premises of the mechanic during normal business hours.

ALL WARRANTIES implied by law, including the warranties of merchantability and fitness for a particular purpose, are hereby limited to the warranty period herein and shall expire at the end of such period.

SPECIFICALLY EXCLUDED: as incidental costs, such as towing fee, car rental charges, travel expenses or accessories and components which are not specifically covered by this WRITTEN WARRANTY, nor are consequential damage such as damage to other accessories and components resulting from a defective part or installation of such part installed or repaired during the repair included in the WRITTEN WARRANTY.

This WRITTEN WARRANTY shall not be varied, supplemented, qualified or interpreted by any prior course of dealings. This WRITTEN WARRANTY shall be null and void if the repair is altered, adjusted or tampered with by any person not authorized by the above named shop. This warranty is non-transferable.
